#### Latest Release

Users should be on either Release 5.2a, 5.2b or 5.2c in August 2019.

When will the next update be available?

Release 5.3a will be available in early September 2019 and will contain important system changes for the upcoming SARS Employer Interim Reconciliation.

5.3a will be **mandatory** for RSA users and must be installed before creating the IRP5 file for import into e@syFile.

### Legislative changes

**RSA Users only** 

#### Low or Interest Free Loan/Debt Fringe Benefit - New Repurchase Rate

The repurchase rate (repo rate) has decreased from 6.75% to 6.50% on 19 July 2019. As from August 2019, the 'low or interest free loan/debt' fringe benefit should be calculated by using the new 'official interest rate'. The 'official interest rate' as defined in sect. 1 of the Income Tax Act: Repo (6.5%) + 1% = 7.50%. View the current market rates <u>here</u>.
