Final Reminder for the Submission of 2018 and Prior Years' Outstanding Return of Earnings (ROE) Report

The Department of Employment and Labour has issued a final reminder notice for the submission of 2018 and prior years' outstanding return of earnings report (OID/W.As.8 report) before 31 December 2019. Failure to submit can result in a penalty.

Employers can submit online at <https://cfonline.labour.gov.za/> or manually at cfcallcentre@labour.gov.za. If employers have discontinued business/operations, or ceased to employ employees, they must inform the office of the Compensation Commissioner in writing at cfcallcentre@labour.gov.za. Zimbabwe – Bonus exemption and other proposed tax changes
